Ladies,

For IRS status, we are classified as a 527, which is a political organization. We are not non-profit. Unfortunately, you will not be able to open a bank account until your club is approved by VFRW and NFRW. VFRW has a board meeting on 10/21, where the Board will vote on ratifying your club. Then the paperwork goes to NFRW for approval. When that is done, you will receive your charter from NFRW, which you can take to the bank as documentation. You can apply for a tax ID number at any time, but I'd advise that you wait until you are approved by VFRW.

I plan to be at your meeting on 10/26, and we can talk at that time.

I am copying our VFRW Treasurer, Fay Williamson, on this. You will be submitting future membership forms and dues to Fay.
